The following terminology applies to these Terms and Conditions, Privacy Statement and Disclaimer Notice and any or all Agreements: "Client", "Costumer", "You" and "Your" refers to you, the person accessing this website and accepting the Company's terms and conditions. "The Company", "Our Company", "Ourselves", "We", "Our" and "Us", refers to our Company. "Party", "Parties", or "Us", refers to both the Client and ourselves, or either the Client or ourselves. All terms refer to the offer, acceptance and consideration of payment necessary to undertake the process of our assistance to the Client in the most appropriate manner, whether by formal meetings of a fixed duration, or any other means, for the express purpose of meeting the Client's needs in respect of provision of the Company's stated services/products, in accordance with and subject to, prevailing law of . REGISTRATION AND USAGE

You will need to register with BuffetFootball to place an order for products and/or services through this website.

In return for permitting you to use this website and benefiting from our services, you agree that any information you provide to us about yourself at any time will be true, accurate, current and complete, and that you will ensure that this information is kept accurate and up to date. If incorrect information is supplied, any contractual obligation Our Company has is immediately null and void.

You need to be 16 years or over to browse BuffetFootball. We don't knowingly collect any information from anyone aged 16 or under. When browsing BuffetFootball you agree to follow our guidelines or instructions and keep in mind that these terms apply to any use of BuffetFootball whether or not you're customer or a subscriber.

You need to be 18 years or over to make a purchase or to become a subscriber. If you're under 18 you will need to use the account of a parent or legal guardian who is at least 18 years of age, with their permission, and this adult will be responsible for all your activities.

PRODUCT AND SERVICES ORDERS

All orders placed through the Website are subject to Our acceptance. This means that BuffetFootball may refuse to accept or may cancel any order, whether or not the order has been confirmed, for any or no reason, and without liability to you or anyone else. If BuffetFootball charge for an order that is cancelled before it being dispatched, BuffetFootball will issue a refund.

Please note that BuffetFootball is a vendor and a design studio. We do not manufacture or stock the products we sell. Order fulfillment is made by the third party/suppliers, and those are liable for the process after a customer's order on our website. Third parties we use for fulfillment may change accordingly. Therefore BuffetFootball cannot be held responsible for the faults of the products/parcels ordered over our website, and/or all the process (payment processing, delivery times, shipping, etc) after you ordered the product from our website. BuffetFootball will do all in it's power to rectify eventual problem(s) between the customer and the suppliers. BuffetFootball strives to provide it's customers with the best quality of services and products, and in such light we choose our fulfillment partners. If there's anything you would suggest to improve upon please contact us.

BuffetFootball uses different third parties for fulfillment of different products, so the shipment of the order may come from multiple suppliers, meaning multiple parcels, with different arrival times.

We cannot guarantee delivery dates and accept no responsibility, apart from advising you of any known delay, for products that are delivered after the estimated delivery date. It is only an average estimation, and some delivery can take longer, or alternatively be delivered much faster. All delivery estimates given at the time of placing and confirming order are subject to change.

Depending from the product, product may be shipped from the EU, US, or China. Generally, printed products are shipped from EU or US, depending on the location of the customer; while other products may be shipped from China.

All taxes (VAT) are managed and paid by the product/service providers in their respective countries, and are not refundable. The price that you pay Us is always the full price advertised on the website. You may be liable to pay your local tax depending on where you are

ordering from. Customers acknowledge their liability for any local sales tax, fees and importation costs applied by their local government by placing an order on our website. These fees vary from country to country and can change frequently. As such BuffetFootball is unable to give any indication as to what these costs may be and customers are advised to seek advice locally before placing an order.

In such case we will not make any refunds and will not resend the product.

Our fulfillment partners may review replacement/return requests only if (a) there is a missing or broken product, or a print error if our fulfillment partner is at fault and (b) We receive a complaint within 30 days from the day the product was delivered or within 30 days after the estimated delivery date, if the product is missing.

We use our best efforts to provide you with the best product images and descriptions, but unfortunately cannot guarantee that colors and details in website images are 100% accurate representations of the product, and sizes might in some cases be approximate.

CANCELLATIONS OF CONTENT CREATING SERVICES

All content creating service subscriptions will remain active until you cancelled. You can cancel your subscription at any time.

Cancellation requests must be submitted at least two (2) business days prior to a billing cycle to avoid the fees for that billing cycle. Billing cycle starts with the first day of the month. To be clear, you will be charged for a billing cycle unless your cancellation request is received by us at least two (2) days before that billing cycle is due to start. We generally do not issue refunds for any unused portion of your subscription.
